RESOLUTION TO ABANDON THE SPECIAL EXCEPTION GRANTED BY RESOLUTION R-78-I 265 APPROVING ZONING PETITION 78-200

WHEREAS, the Board of County Commissioners, as the governing body of Palm Beach County, Florida, pursuant to the authority vested in Chapters 125 and 163, Florida Statutes, is authorized and empowered to consider petitions related to zoning; and

WHEREAS, Zoning Petition 78-200 was presented to the Board of County Commissioners at a public hearing on September 25, 1978; and

WHEREAS, Resolution R-78-I 265 approving this petition was adopted by the Board of County Commissioners on October 10, 1978; and

WHEREAS, Resolution R-78-1265 granted approval of the request for an Official Zoning Map Amendment (Rezoning) from Neighborhood Commercial District (CN) and Residential Multiple Family District (High Density) to General Commercial District (CG); with a further special exception to allow the Salvation Army Lodge Facility, including Administrative Offices with storage and Thrift Store Sales; and

WHEREAS, the Zoning Director has determined the request to administratively abandon the special exception granted under Resolution R-78-1265, as provided for in Article 5 (Development Review Procedures) of the Palm Beach County Unified Land Development Code (Ordinance 92-20, as amended), meets the criteria and finds that:

- 1. All conditions of approval have been met;
- 2. There is no reliance by other parties on additional performances;
- 3. Consent of all property owners have been received; and

WHEREAS, the Zoning Director has administratively abandoned the special exception granted under Resolution R-78-1265, as provided for in Article 5 (Development Review Procedures) of the Palm Beach County Unified Land Development Code (Ordinance 92-20, as amended); and

WHEREAS, the Zoning Director presented the abandonment of the special exception granted under Resolution R-78-I 265 to the Board of County Commissioners for ratification on May 25, 2000; and

WHEREAS, Article 5, Section 5.3.D.9 (Action by Board of County Commissioners) of the Palm Beach County Unified Land Development Code requires that action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that the Special Exception granted under Resolution R-78-1265, approving Zoning Petition 78-200, the petition of Salvation Army, by Ernest W. Holz, Vice President, agent, for a special exception to **allow the** Salvation Army Lodge facility, including administrative offices with storage and thrift store sales is hereby abandoned.
