## RESOLUTION CORRECTING RESOLUTION R-2000-1 568 RESOLUTION APPROVING ZONING PETITION OF CASCADES LAKES, LTD. A FLORIDA PARTNERSHIP (LESTER PUD) PETITION DOA98-055(B)

WHEREAS, CASCADES LAKES, LTD. A FLORIDA PARTNERSHIP, petitioned the Palm Beach County Board of County Commissioners on September 28, 2000 for a Development Order Amendment (DOA) to add land area and units; and

WHEREAS, Resolution R-2000-1 568, adopted on September 28, 2000 confirming the action of the Board of County Commissioners inadvertently contained an error in Condition E.8.b of Exhibit C; and

WHEREAS, Condition E.8.b of Exhibit C of Resolution R-2000-1 568 should have read as follows:

E.8. In order to comply with the mandatory Traffic Performance Standards, the Developer shall be restricted to the following phasing schedule:

## **Developer Road Projects:**

**b.** Condition E.8.b. of Resolution R-98-2045, Petition **PDD98-055** which currently states:

Building Permits for no more than 255 adult single-family housing units (2043 daily project trips) shall be issued until contract is let for the construction of Lake Ida Road from Military Trail to Congress Avenue to a 4-lane median divided cross-section. Applicant shall assure construction of this road improvement by entering into an Adequate Public Facilities Agreementwith Palm Beach County before or at the Board of County Commission meeting at which the Development Order is approved for this project. (BLDG. PERMIT: MONITORING - Eng.)

Is hereby amended to read:

Building Permits for more than 266 total dwelling units shall not be issued until <u>contract for the</u> construction has <u>begun</u> <u>been let</u> for Lake Ida Rd as a 4-lane section from Military Trail to Congress Ave. plus the appropriate paved tapers. (BLDG PERMIT: MONITORING-Eng)

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

- 1. The foregoing recitals are hereby affirmed and ratified.
- 2. Condition E.8.b of Exhibit C of Resolution R-2000-1568 is hereby corrected.
