RESOLUTION APPROVING ZONING PETITION CA00-073 CLASS A CONDITIONAL USE PETITION OF ALBERT JACKMAN BY ALBERT JACKMAN, AGENT (MR. A'S GROCERY)

WHEREAS, the Board of County Commissioners, as the governing body of Palm Beach County, Florida, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the Board of County Commissioners, pursuant to Article 5 (Development Review Procedures) of the Palm Beach County Unified Land Development Code (Ordinance 92-20, as amended) is authorized and empowered to consider, approve, approve with conditions or deny Class A Conditional Uses; and

WHEREAS, the notice and hearing requirements, as provided for in Article 5 of the Palm Beach County Unified Land Development Code have been satisfied; and

WHEREAS, Zoning Petition CA00-073 was presented to the Board of County Commissioners at a public hearing conducted on January 252001; and

WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the petitioner and other interested parties, the recommendations of the various county review agencies, and the recommendations of the Zoning Commission; and

WHEREAS, this approval is subject to Article 5, Section 5.8 (Compliance with Time Limitations) of the Palm Beach County Unified Land Development Code (ULDC) and other provisions requiring that development commence in a timely manner; and

WHEREAS, the Board of County Commissioners made the following findings of fact:

- 1. This Class A Conditional Use is consistent with the Palm Beach County Comprehensive Plan.
- 2. This Class A Conditional Use complies with relevant and appropriate portions of Article 6, Supplementary Use Standards of the Palm Beach County Unified Land Development Code.
- 3. This Class A Conditional Use is consistent with the requirements of the Palm Beach County Unified Land Development Code.
- 4. This Class A Conditional Use, with conditions as adopted, is compatible as defined in the Palm Beach County Unified Land Development Code and generally consistent with the uses and character of the land surrounding and in the vicinity of the land proposed for development.
- 5. This Class A Conditional Use, with conditions as adopted, complies with standards imposed on it by all other applicable provisions of the Palm Beach County Unified Land Development Code for use, layout, function, and general development characteristics.
- 6. This Class A Conditional Use meets applicable local land development regulations.

- 7. This Class A Conditional Use, with conditions as adopted, minimizes adverse effects, including visual impact and intensity of the proposed use on adjacent lands.
- 8. This Class A Conditional Use has a concurrency determination and complies with Article 11, Adequate Public Facility Standards of the ULDC.
- This Class A Conditional Use, with conditions as adopted, minimizes 9. environmental impacts, including but not limited to water, air, stormwater management, wildlife, vegetation, wetlands and the natural functioning of the environment.
- This Class A Conditional Use, with conditions as adopted, will result in logical, 10. timely and orderly development patterns.

WHEREAS. Article 5 of the Palm Beach County Unified Land Development Code requires that the action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Zoning Petition CA00-073, the petition of Albert Jackman, by Albert Jackman, agent, for a Class A Conditional Use (CA) to allow a convenience store in the Community Commercial (CC) Zoning District, on a parcel of land legally described in EXHIBIT A, attached hereto and made a part hereof, and generally located as shown on a vicinity sketch as indicated in EXHIBIT B, attached hereto and made a part hereof, was approved on January 25, 2001, subject to the conditions of approval described in EXHIBIT C, attached hereto and made a part hereof.

Commissioner McCarty moved for the approval of the Resolution.

VICINITY SKETCH




EXHIBIT C

CONDITIONS OF APPROVAL

A. ALL PETITIONS

1. Development of the site is limited to the uses and site design as approved by the Board of County Commissioners. The approved site plan is dated October 18, 2000. All modifications must be approved by the Board of County Commissioners unless the proposed changes are required to meet conditions of approval or are in accordance with the ULDC. (ONGOING: ZONING)

B. <u>LANDSCAPING ALONG NORTH PROPERTY LINE</u> (ABUTTING RESIDENTIAL)

- 1. Prior to the Certificate of Occupancy for the convenience store or March 31, 2001 whichever comes first, the six (6) foot high concrete wall shall be completed with a smooth or rough stucco finished appearance on both sides. (CO/DATE: LANDSCAPE)
- 2. Along the interior side of the required wall, the property owner shall install twenty-four (24) inch high shrub or hedge material spaced no more than twenty four (24) inches on center, to be maintained at a minimum height of sixty (60) inches. (CO/ONGOING: LANDSCAPE)

C. <u>LANDSCAPE INTERIOR</u>

1. Petitioner shall install a landscaped island with two (2) native shade trees and type D curbing to replace the striped "no parking" area located in the southeast corner of the property. (CO/DATE: LANDSCAPE)

D. <u>PARKING</u>

 No overnight storage or parking of vehicles or trucks shall be permitted on site. (ONGOING: CODE ENF)

E. <u>ENGINEERING</u>

1. The property owner shall convey to Palm Beach County Land Development Division by road right-of-way warranty deed for a 25 foot "Corner Clip" at Miner Road and Coral Street, prior to June 1, 2001. Developer shall provide Palm Beach County with sufficient documentation acceptable to the Right of Way Acquisition Section to ensure that the property is free of all encumbrances and encroachments. (DATE/BLDG PERMIT: MONITORING-Eng)

F. SIGNS

- 1. Freestanding point of purchase sign shall be limited to only the Miner Road frontage as follows:
 - Maximum sign height, measured from finished grade to highest point eight (8) feet;
 - b. Maximum sign face area per side 40 square feet;
 - c. Maximum number of signs one (1); and
 - d. Style monument style only. (CO: BLDG)

- Wall signs shall be limited to the east and south facades of the building and shall be limited to a maximum twenty (20) square feet per facade. (ONGOING/ BLDG: CODE ENF)
- 3. No temporary signs or banners shall be permitted. (ONGOING: CODE ENF)

G. <u>USE LIMITATIONS</u>

- Outdoor retail business activities or vendors shall not be allowed on site. (ONGOING: CODE ENF)
- Outdoor storage or temporary containers/ trailers shall not be permitted on the property. (ONGOING: CODE ENF)

H. <u>COMPLIANCE</u>

- In granting this approval, the Board of County Commissioners relied upon the oral and written representations of the petitioner both on the record and as part of the application process. Deviations from or violation of these representations shall cause the approval to be presented to the Board of County Commissioners for review under the compliance condition of this approval. (ONGOING: MONITORING - Zoning)
- 2. Failure to comply with any of the conditions of approval for the subject property at any time may result in:
 - a. The issuance of a stop work order; the issuance of a cease and desist order; the denial or revocation of a building permit; the denial or revocation of a Certificate of Occupancy; the denial of any other permit, license or approval to any developer, owner, lessee, or user of the subject property; the revocation of any other permit, license or approval from any developer, owner, lessee, or user of the subject property; revocation of any concurrency; and/or
 - b. The revocation of the Official Map Amendment, Conditional Use, Requested Use, Development Order Amendment, and/or any other zoning approval; and/or
 - c. A requirement of the development to conform with the standards of the ULDC at the time of the finding of non-compliance, or the addition or modification of conditions reasonably related to the failure to comply with existing conditions; and/or
 - d. Referral to code enforcement: and/or
 - e. Imposition of entitlement density or intensity.

Staff may be directed by the Executive Director of PZ&B or a majority vote of the Code Enforcement Board to schedule a Status Report before the body which approved the Official Zoning Map Amendment, Conditional Use, Requested Use, Development Order Amendment, and/or other zoning approval, in accordance with the provisions of Section 5.8 of the ULDC, in response to any flagrant violation and/orcontinued violation of any condition of approval.

Appeals of any departmental administrative actions hereunder may be taken to the Palm Beach County Board of Adjustment or as otherwise provided in the Unified Land Development Code (ULDC), as amended. Appeals of any revocation of an Official Zoning Map Amendment, Conditional Use, Requested Use, Development Order Amendment or other actions based on a Board of County Commission decision shall be by petition for writ of certiorari to the Fifteenth Judicial Circuit. (MONITORING)
