RESOLUTION CORRECTING RESOLUTION R-2001-0613
RESOLUTION APPROVING ZONING PETITION OF
ST. PAUL AME CHURCH
PETITION DOA97-029(A)

WHEREAS, St. Paul Ame Church petitioned the Palm Beach County Board of County Commissioners on April 26, 2001 for a Development Order Amendment (DOA) to reconfigure site plan and add square footage; and

WHEREAS, Resolution R-2001-0613, adopted on April 26, 2001 confirming the action of the Board of County Commissioners inadvertently contained an error in Condition J.I of Exhibit C; and

WHEREAS, Condition J.I of Exhibit C of Resolution R-2001-0613 should have read as follows:

1. Condition J.I of Resolution R-97-2070, Petition CA97-029 which currently states:

All signage, including wall mounted and entrance wall signs, shall be limited as follows:

- a. **Maximum sign height, measured from finished grade to highest point - eight (8) feet;**
- b. **Maximum sign face area per side - 60 square feet;**
- c. **Maximum number of signs - one (1) for Haverhill Road; and,**
- d. **Style - monument style only. (CO: BLDG)**

Is hereby amended to read:

Freestanding point of purchase signs fronting on Haverhill Road shall be limited as follows:

- a. Maximum sign height, measured from finished grade to highest point - ~~six (60)~~ six (6) feet;
- b. Maximum sign face area per side - 60 square feet;
- c. Maximum number of signs - one (1); and
- d. Style - monument style only. (CO: BLDG)

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

1. The foregoing recitals are hereby affirmed and ratified.
2. Condition J.I of Exhibit C of Resolution R-2001-0613 is hereby corrected.

Commissioner Roberts moved for the approval of the Resolution.
