## RESOLUTION REVOKING RESOLUTION R-79-719 AFFIRMING THE ADMINISTRATIVE ABANDONMENT OF ZONING PETITION 1979-054

## **EXHIBIT A**

## **LEGAL DESCRIPTION**

THE SOUTHWEST COERN OF THE NORTHEEAST 1/4 OF SOUTHEAST 1/4 OF THE NORTHEAST 1/4 OF SECTION 25, TOWNSHIP 43 SOUTH, RNAGE 42 EAST, SAID ONE-HALF ACREA BEING IN TRACT 8 OF WHIDDEN'S GARDENS, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:
