WHEREAS, St. Hermans Orthodox Church and Ann Throgmorton petitioned the Palm Beach County Board of County Commissioners on April 26, 2001 for Development Order Amendment (DOA) to add/delete land area, reconfigure site plan, add and relocate an access point and to modify/delete conditions of approval; and

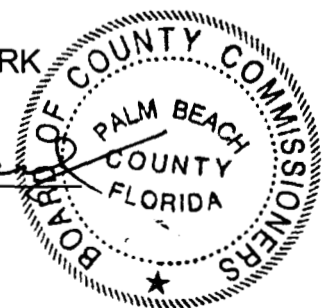

LEGAL DESCRIPTION

LEGAL DESCRIPTION:

A PORTION OF TRACT 1 IN THE NORTHWEST $\frac{1}{4}$ OF SECTION 12, TOWNSHIP 45 SOUTH, RANGE 42 EAST, OF THE "AMENDED PLAT OF SEC. 12 TWP. 45 S. R. 42 E." ACCORDING TO THE PLAT THEREOF AS RECORDED IN PLAT BOOK 9 AT PAGE 74 OF THE PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCE AT NORTH $\frac{1}{4}$ CORNER OF SAID SECTION 12; THENCE SOUTH $04^{\circ}39'09''$ WEST ON THE EAST LINE OF THE NORTHWEST $\frac{1}{4}$ OF SAID SECTION 12 FOR 402.54 FEET; THENCE NORTH $89^{\circ}12'21''$ WEST FOR 67.42 FEET TO THE POINT OF BEGINNING, SAID POINT BEING ON THE WESTERLY RIGHT-OF-WAY LINE OF MILITARY TRAIL AND ON THE ARC OF A 11,392.16 FOOT RADIUS NON-TANGENT CURVE CONCAVE TO THE WEST WHOSE RADIUS POINT BEARS NORTH $85^{\circ}44'20''$ WEST; THENCE SOUTHERLY ON THE ARC OF SAID CURVE AND SAID WESTERLY RIGHT-OF-WAY LINE, THROUGH A CENTRAL ANGLE OF $00^{\circ}23'29''$ FOR AN ARC DISTANCE OF 77.81 FEET TO A POINT OF TANGENCY; THENCE SOUTH $04^{\circ}39'09''$ WEST FOR 130.00 FEET; THENCE SOUTH $86^{\circ}59'19''$ WEST FOR 30.28 FEET; THENCE NORTH $89^{\circ}12'21''$ WEST FOR 160.88 FEET; THENCE NORTH $04^{\circ}39'09''$ EAST FOR 209.84 FEET; THENCE SOUTH $89^{\circ}12'21''$ EAST FOR 190.69 FEET TO THE POINT OF BEGINNING.

SAID LANDS SITUATE, LYING, AND BEING IN PALM BEACH COUNTY, FLORIDA AND CONTAINING 39,943 SQUARE FEET (0.9170 ACRES) MORE OR LESS.
