RESOLUTION ABANDONING ZONING PETITION 89-92  
ADMINISTRATIVE ABANDONMENT OF RESOLUTIONS  
R-90-359 AND R-92-942  
PETITION OF ELSA RIVERS

WHEREAS, the Board of County Commissioners, as the governing body of Palm Beach County, Florida, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, Zoning Petition 89-92 was presented to the Board of County Commissioners at public hearings conducted on February 27, 1990 and July 7, 1992, and Resolutions R-90-359, and R-92-942, approving this petition was adopted by the Board of County Commissioners; and

WHEREAS, the Zoning Director has determined that the request to administratively abandon the development order (Resolutions R-90-359, and R-92-942), as provided for in Article 5 (Development Review Procedures) of the Palm Beach County Land Development Code (Ordinance **92-20**), as amended, meets the requirements contained therein; and

WHEREAS, the Zoning Director has administratively abandoned the development order (Resolutions R-90-359, and R-92-942) as provided for in Article 5 (Development Review Procedures) of the Palm Beach County Land Development Code (Ordinance **92-20**), as amended; and

WHEREAS, the Zoning Director presented the abandonment of the development order (Resolutions R-90-359, and R-92-942) to the Board of County Commissioners for ratification on April 28, 1994; and

WHEREAS, Article 5, Section 5.3.D.9 (Action by Board of County Commissioners) of the Palm Beach County Land Development Code requires that the action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Resolutions R-90-359, and R-92-942, approving Zoning Petition 89-92, the petition of Elsa Rivers, for a Planned Commercial Development including auto service station, is hereby revoked.

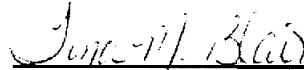
