RESOLUTION REVOKING RESOLUTION R-79-222 AFFIRMING THE ADMINISTRATIVE ABANDONMENT OF ZONING PETITION 79-222

WHEREAS, the Zoning Director presented the abandonment of the development order to the Board of County Commissioners for ratification on April 27, 1995; and

WHEREAS, Article 5, Section 5.3.D.9 (Action by Board of County Commissioners) of the Palm Beach County Land Development Code requires that the action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Resolution R-1771, approving Zoning Petition 79-222, the petition of Robert C. Bridges for a Special Exception to allow a Planned Commercial Development is hereby revoked.
