RESOLUTION APPROVING ZONING PETITION **295-104** OFFICIAL ZONING MAP AMENDMENT (REZONING) WITH A NATIVE ECOSYSTEM OVERLAY DISTRICT PETITION OF DOJR DEVELOPMENT COMPANY INC. BY CARL BENGTSON, AGENT PARKVIEW ESTATES

WHEREAS, the Board of County Commissioners, as the governing body of Palm Beach County, Florida, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements, as provided for in Article 5 (Development Review Procedures) of the Palm Beach County Unified Land Development Code (Ordinance 92-20), have been satisfied; and

WHEREAS, Zoning Petition 295-104 was presented to the Board of County Commissioners at a public hearing conducted on April 25, 1996; and

WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the petitioner and other interested parties, the recommendations of the various county review agencies, and the recommendation of the Zoning Commission; and

WHEREAS, the Board of County Commissioners made the following findings of fact:

- 1. This official zoning map amendment (rezoning) is consistent with the Palm Beach County Comprehensive Plan;
- 2. This official zoning map amendment (rezoning) is consistent with the requirements of the Palm Beach County Unified Land Development Code;
- 3. This official zoning map amendment (rezoning) is compatible with surrounding uses and zones, as defined in the Palm Beach County Unified Land Development Code, is generally consistent with existing uses and zones surrounding the subject land, and is the appropriate zoning district for the land;
- 4. This official zoning map amendment (rezoning) does not result in significantly adverse impacts on the natural environment, including but not limited to water, air, stormwater management, wildlife, vegetation, wetlands, and the natural functioning **of** the environment;
- 5. This official zoning map amendment (rezoning) will result in a logical and orderly development pattern;
- 6. This official zoning map amendment (rezoning) complies with Article 11, (Adequate Public Facilities) of the Palm Beach County Unified Land Development Code, Ordinance 92-20;
- 7. This official zoning map amendment (rezoning) is consistent with the requirements **of** all other applicable local land development regulations; and,
- 8. A Native Ecosystem Overlay is appropriate for the subject property and consistent with the Comprehensive Plan.



EXHIBIT C

VOLUNTARY COMMITMENTS

- A. <u>LANDSCAPING ALONG SOUTH PROPERTY LINE</u> (ABUTTING NORTH PROFERTY LINE OF PALMETTO PARK WOODS PUD)
 - 1. Landscaping along the south property line abutting the north property line of Palmetto Park Woods PUD shall be upgraded to include:
 - a. A five (5) foot wide landscape easement; and
 - b. Twenty four (24) inch high shrub or hedge material spaced no more than twenty four (24) inches on center at installation, to be maintained at a minimum height of forty-eight (48) inches. (CO: LANDSCAPE-Zoning)

B. SIGN

 The existing billboard located in the southwest corner of the property shall be removed prior to September 3, 1998. (DATE: MONITORING - Zoning)

C. <u>MASS TRANSIT</u>

- Prior to final certification of the master plan or site plan by the Development Review Committee, whichever occurs first, the petitioner shall amend the plan to indicate bus access and/or a bus stop(s) on or adjacent to the subject property. Bus access and/or bus stops shall be located and constructed by the petitioner in a manner acceptable to the Palm Beach County School Board, Palm Tran, and County Engineer. (DRC: ZONING - School Board/Eng/Planning)
- 2. The petitioner shall dedicate additional right-of-way to accommodate this requirement, if requested by the County Engineer. Bus stops, if required, shall include, at a minimum, a covered shelter, continuous paved pedestrian and bicycle access from the subject property or use, and bicycle rack. (DRC: ZONING -School Board/Eng/Planning)
- 3. The property owner shall negotiate, in good faith, a contract for a proportionate share of the cost of operation and maintenance of mass transit generated by this projects identifiable impacts in accordance with an official County program adopted for such purpose. This condition F shall remain in effect until (date-one year from approval) (DATE: MONITORING Eng)

E. <u>ENGINEERING</u>

- 1. Prior to technical compliance for the first plat the property owner shall convey a roadway construction easement to Palm Beach County. This roadway construction easement shall contain an isosceles trapezoid connecting the required corner clips across this property owners road right of way. Construction within this easement shall conform to Palm Beach County Standards. (TC: ENG).
- 2. LANDSCAPE IN MEDIAN
 - A. Prior to technical compliance by the Land Development Division, the property owner shall apply to the Palm Beach County Engineering and Public Works Department for a permit to landscape the median of the right of way from this project's

Petition 295-104 Project No. 0678 eastern property line to the western property line of Palmetto Park Woods PUD. When permitted by Palm Beach County Department of Engineering and Public Works, landscaping shall, at a minimum, consist of the "Low cost Planting Concept" outlined in the Palm Beach County Engineering and Public Works Department March 1994 Streetscape Standards and shall be consistent with the landscaping theme adopted for this roadway. All landscape material, installation, and maintenance requirements shall be subject to the standards as set forth by the Streetscape Standards. If all xeriscape material is utilized, the watering of the plant material during the initial heal-in period shall be the responsibility of the property owner. Alternative species other than those listed in the County standards may be allowed subject to approval by the County Engineer. (TC: ENG)

- All required median landscaping including an irrigation system, if required, shall be at the в. All an property owners expense. All landscape material shall also be the perpetual maintenance obligation of the property owner its successors, heirs or assignees or duly established Property Owner's Association and/or Homeowners's Association, Perpetual maintenance includes, but is not limited to, pruning, fertilizing, irrigation, and alternate watering of Xeriscape material during periods of watering of drought in order to maintain healthy plant All landscape material shall be material. installed concurrent with the improvements with the first plat. However, given the event that the subject property or properties located on the south side of Palmetto Park Road adjacent to Palmetto Park Woods PUD is rezoned or re-platted within five years of the date of this approval (May 23, 1996), the subject property owner shall share in the expense of this commitment by reimbursing the petitioner one half of the installation expense associated with the median landscaping adjacent to the subject property or properties. (DATE/PLAT: ENG)
- C. Declaration of Covenants and Restriction Documents shall be established or amended as required, prior to recordation of the first plat to reflect this obligation. (PLAT: ENG)
