WHEREAS, the Board of County Commissioners, as the governing body of Palm Beach County, Florida, pursuant to the authority vested in Chapter 163 and Chapter **125**, **Florida** Statutes, is **authorized and** empowered to consider petitions relating **to** zoning; and

WHEREAS, the Board of County Commissioners, pursuant to Article 5 (Development Review Procedures) of the Palm Beach County Unified Land Development Code (Ordinance 92-20, as amended) is authorized and empowered to consider, approve, approve with conditions or deny Class A Conditional Uses; and

WHEREAS, the notice and hearing requirements, as provided for in Article 5 of the Palm Beach County Unified Land Development Code have been satisfied; and

WHEREAS, Zoning Petition CA96-106 was presented to the Board of County Commissioners at a public hearing conducted on January 6, 1997; and

WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the petitioner and other interested parties, the recommendations of the various county review agencies, and the recommendations of the Zoning Commission; and

WHEREAS, this approval is subject to Article 5, Section **5.8** (Compliance with Time Limitations) of the Palm Beach County Unified Land Development Code (ULDC) and other provisions requiring that development commence in a timely manner; and

WHEREAS, the Board of County Commissioners made the following findings of fact:

- 1. This Class A Conditional Use is consistent with the Palm Beach County Comprehensive Plan.
- 2. This Class A Conditional Use complies with relevant and appropriate portions of Article 6, Supplementary Use Standards of the Palm Beach County Unified Land Development Code.
- 3. This Class A Conditional Use is consistent with the requirements of the Palm Beach County Unified Land Development Code.
- 4. This Class A Conditional Use, with conditions as adopted, is compatible as defined in the Palm Beach County Unified Land Development Code and generally consistent with the uses and character of the land surrounding and in the vicinity of the land proposed for development.
- **5.** This Class A Conditional Use, with conditions as adopted, complies with standards imposed on it by all other applicable provisions of the Palm Beach County Unified Land Development Code for use, layout, function, and general development characteristics.
- 6. This Class **A** Conditional Use meets applicable local land development regulations.

- 7. This Class A Conditional Use, with conditions as adopted, minimizes adverse effects, including visual impact and intensity of the proposed use on adjacent lands.
- 8. This Class A Conditional Use **has** a concurrency determination and complies with Article **11**, Adequate Public Facility Standards of the ULDC.
- **9.** This Class A Conditional Use, with conditions **as** adopted, minimizes environmental impacts, including but not limited to water, air, stormwater management, wildlife, vegetation, wetlands and **the** natural functioning **of** the environment.
- **10.** This Class A Conditional Use, with conditions as adopted, will result in logical, timely and orderly development patterns.

WHEREAS, Article 5 of the Palm Beach County Unified Land Development Code requires that the action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Zoning Petition **CA96-106**, the petition of Correctional Services Corp., by John Corbett, agent, for a Class **A** Conditional UseClass **A** Conditional Use Correction Facility in the Glades Area Economic Overlay (GA-O) District in the Agricultural Residential (AR) Zoning District, on a parcel of land legally described in EXHIBIT A, attached hereto and made a part hereof, and generally located as shown *on* a vicinity sketch as indicated in EXHIBIT B, attached hereto and made a part hereof, was approved on January **6**, **1997**, subject to the conditions of approval described in EXHIBIT C, attached hereto and made a part hereof.



EXHIBIT C

CONDITIONS OF APPROVAL

A. <u>ALL PETITIONS</u>

1. Development of the site is limited to the uses and site design as approved by the Board of County Commissioners. The approved site plan is dated October 25, 1996. All modifications must **be** approved by the Board of County Commissioners unless the proposed changes are required to meet conditions of approval or are **in** accordance with the ULDC. (ONGOING: ZONING)

B. <u>LANDSCAPE</u>

1. Prior to final Development Review Committee certification, an Alternative Landscape Betterment Plan shall be submitted for landscaping along the north side of Morgan West Road and public parking areas. In accordance with the Alternative Landscape Betterment Plan provisions of the ULDC the petitioner shall participate in an off-site contribution to the City of Pahokee for landscaping purposes. (DRC: LANDSCAPE-Zoning)

E. <u>ENGINEERING</u>

1. The Property owner shall construct Morgan Road from State Road 15 west to the project's entrance road. Construction shall be to collector street standards, 2 - 12 foot travel lanes, including a guard rail on the south side of Morgan Road. This construction shall be concurrent with paving and drainage improvements for the site. Any and all costs associated with the construction shall be paid by the property owner. These costs shall include, but are not limited to, utility relocations and acquisition of any additional required right-of-way. Permits required by Palm Beach County for this construction shall be obtained prior to the issuance of the first Building Permit. Construction shall be completed prior to the issuance of the first Certificate of Occupancy. (CO: MONITORING/Eng)

F. <u>COMPLIANCE</u>

- 1. Failure to comply with any of the conditions of approval for the subject property at any time may result in:
 - a. The issuance of a stop work order; the issuance of a cease and desist order; the denial or revocation of a building permit; the denial or revocation of a Certificate of Occupancy; the denial of any other permit, license or approval to any developer, owner, lessee, or user of the subject property; the revocation of any other permit, license or approval from any developer, owner, lessee, or user of the subject property; and/or
 - b. The revocation of the Official Map Amendment, Conditional Use, Requested Use, Development Order Amendment, and/or any other zoning approval; and/or
 - c. A requirement of the development to conform with the standards of the ULDC at the time of the finding of non-compliance, or the addition or modification of conditions reasonably related to the fail ure to comply with existing conditions; and/or

- d. Referral to code enforcement; and/or
- e. Imposition of entitlement density or intensity.

Appeals of any departmental administrative actions hereunder may be taken to the Palm Beach County Board of Adjustment or as otherwise provided in the Unified Land Development Code (ULDC), as amended. Appeals of any revocation of an Official Zoning Map Amendment, Conditional Use, Requested Use, Development Order Amendment or other actions based on a Board of County Commission decision shall be by petition for writ of certiorari to the Fifteenth Judicial Circuit. (MONITORING)
