RESOLUTION APPROVING RECOMMENDATION OF STATUS REPORT NO. SR 87-143.7 TO REVOKE THE SPECIAL EXCEPTION FOR PROPERTY PREVIOUSLY GRANTED A SPECIAL EXCEPTION BY RESOLUTION NO. R-89-586 APPROVING THE PETITION OF JOHN D. AND MAUREEN CORBITT PETITION NO. 87-143

WHEREAS, the Board of County Commissioners, **as** the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, systematic monitoring and review of approved zoning actions help implement the goals and objectives of the Comprehensive Plan; and

WHEREAS, the notice and hearing requirements as provided for in Section **5.8** of the Palm Beach County Land Development Code have been satisfied; and

WHEREAS, pursuant to Section **5.8**, Status Report SR **87-143.7** was presented to the Board of County Commissioners of Palm Beach County at a public hearing conducted on May **28**, 1998; and

WHEREAS, the Board of County Commissioners has reviewed Status Report SR **87-143.7** and considered testimony, and the recommendations of the various county review agencies; and

WHEREAS, Section **5.8** of the Palm Beach County Land Development Code authorizes the Board of County Commissioners to revoke Special Exceptions; and

WHEREAS, the Board of County Commissioners made the following findings of fact:

- 1. The revocation of the Special Exception is consistent with the Palm Beach County Comprehensive Plan.
- 2. The revocation of the Special Exception **is** consistent with the Palm Beach County Unified Land Development Code.
- 3. The Special Exception which permits a commercial radio, TV, microwave transmission, relay station and tower, and accessory equipment building is not consistent with the Unified Land Development Code.
- **4.** The property owner has not utilized the development order since it was approved over nine years ago.

WHEREAS, Section **5.3** of the Land Development Code requires that the action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that the recommendation of Status Report No. SR 87-143.7, to revoke the Special Exception previously granted by the approval of the petition of John D. and Maureen Corbitt, Petition No. 87-143, confirmed by the adoption of Resolution R-89-586, which permits a commercial radio, TV, microwave transmission, relay station and tower, and accessory equipment building, on a parcel of land lying on a portion of Tract 6, and the East 1/2 of Tract 7, Block 5, Palm Beach Farms Company Plat No. 3, Section 34, Township 43 South, Range 42 East, as recorded in Plat Book 2, Pages 45 thru 54, inclusive; being more particularly described as follow:
