The design of the accessway connection shall meet all ADA requirements and be approved by the Zoning Division and the Engineering Department. Security nates may be provided and may be closed at night. (DRC: ZONING/ENG)

- 1. The foregoing recitals are hereby affirmed and ratified.
- 2. Condition C.4 of Exhibit C of Resolution R-98-1315 is hereby corrected.
