## RESOLUTION CORRECTING RESOLUTION R-98-727 RESOLUTION APPROVING ZONING PETITION OF RICHARD CASTOR PETITION PDD97-118

WHEREAS, Richard Castor, petitioned the Palm Beach County Board of County Commissioners on May 28, 1998 for an Official Zoning Map Amendment from Agricultural Residential (AR) to Multiple Use Planned Development (MUPD); and

WHEREAS, Resolution R-98-727, adopted on May 28,1998 confirming the action of the Board of County Commissioners inadvertently contained errors in Conditions L.I, L.2 and N.I of Exhibit C; and

WHEREAS, Conditions L.1, L.2 and N.1 of Exhibit C of Resolution R-98-727 should have read as follows:

- L.I Freestanding sign fronting on Jog Road shall be limited as follows:
  - a. Maximum sign height-twelve (12) eight (8) feet measured from the adjacent sidewalk to the highest point;
  - b. Maximum sign face area per side -one hundred (100) ninetv-six(96) square feet;
  - **c.** Maximum number of signs one (1);
  - **d.** Monument style only. (CO: BLDG)
- L.2 Freestanding sign fronting on the <u>corner of **Jog**</u> Road <u>and the</u> easement shall be limited as follows:
  - a. Maximum sign height- eight(8) twelve (12) feet; measured from finished grade to the highest point
  - b. Maximum sign face area per side ninety six (96) one hundred (100) square feet;
  - c. Maximum number of signs one (1);
  - **d.** Monument style only. (CO: BLDG)
- N.I The property shall be restricted to the following uses:
  - a. Financial institution;
  - b. Office, business or professional;
  - C Medical office or dental clinic;
  - d. Florist:

- e. Personal services;
- f. General retail; (See Condition M.5)
- g. Laundry services;
- h. Newsstand or gift shop;
- Printing or copying services;
- j. Restaurant (no primary delivery services, fast food, or drive thru window);
- **k.** Veterinary clinic (no overnight boarding or outdoor runs).

This condition is superseded by Conditions I.1, I.2 and I.3
