- E.I. The Property owner shall construct:
 - a. Rightturn lanewest approach on Okeechobee Boulevardat the projects main entrance.
 - b. Prior to January 1, 1998 1999 or prior to site plan approval, whichever shall first occur, the property owner shall obtain a safe sight easement from the property owner to the south. If a safe sight easement is not able to be obtained, then the site plan shall be amended to reflect the elimination of left turns out and right turns out at the projects middle entrance with the construction of a directional median opening to be constructed by this property owner. (DATE/DRC APPROVAL: MONITORING-ENG)

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

- 1. The foregoing recitals are hereby affirmed and ratified.
