WHEREAS, the legal description of said resolution should have read:

on a parcel of land lying in Lots 3 through 8, inclusive, Block 31 according to the plat of WESTGATE ESTATES, Northern Section, as recorded in Plat Book 8 at Pages 38, and being in Section 30, Township 43 South, Range 43 East.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

- 1. The foregoing recitals are hereby affirmed and ratified.
- 2. The legal description of Resolution No. R-97-1297 is hereby amended.
