## RESOLUTION REVOKING RESOLUTION R-1981-0205 AFFIRMING THE ADMINISTRATIVE ABANDONMENT OF ZONING PETITION SE1980-232

WHEREAS, the Board of County Commissioners, as the governing body of Palm Beach County, Florida, pursuant to the authority vested in Chapters 125 and 163, Florida Statutes, is authorized and empowered to consider petitions related to zoning; and

WHEREAS, Zoning Petition SE1980-232 was presented to the Board of County Commissioners at a public hearing on January 29, 1981; and

WHEREAS, Article 2.A.1.K (Public Hearing Procedures) of the Palm Beach County Unified Land Development Code requires that action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Resolution R-1981-0205, approving Zoning Petition SE1980-232, the petition of William T. Bellew, for a SPECIAL EXCEPTION to allow a Commercial Sales and Service Enterprise and a Commercial Stable is hereby revoked.
