RESOLUTION REVOKING RESOLUTION R-1980-0518 AFFIRMING THE ADMINISTRATIVE ABANDONMENT OF ZONING PETITION SE1980-052

WHEREAS, Article 2.A.1.K (Public Hearing Procedures) of the Palm Beach County Unified Land Development Code requires that action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Resolution R-1980-0518, approving Zoning Petition SE1980-052, the petition of Patricia Perkins, for a Special Exception to allow the parking of one (1) mobile home as a temporary residence is hereby revoked.
