RESOLUTION APPROVING RECOMMENDATION OF STATUS REPORT NO. SR 1998-066 TO APPROVE A DEVELOPMENT ORDER AMENDMENT TO AMEND CONDITIONS OF APPROVAL OF RESOLUTION NO. R-1999-0701 WHICH APPROVED THE CONDITIONAL USE A OF LAKE WORTH 7TH DAY ADVENTIST CHURCH PETITION NO. 1998-066

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, systematic monitoring and review of approved zoning actions help implement the goals and objectives of the Comprehensive Plan.

WHEREAS, the notice and hearing requirements as provided for in Article 2.E of the Palm Beach County Unified Land Development Code have been satisfied; and

WHEREAS, pursuant to Article 2.E, Status Report SR 1998-066 was presented to the Board of County Commissioners of Palm Beach County at a public hearing conducted on April 28, 2005; and

WHEREAS, the Board of County Commissioners has reviewed Status Report SR 1998-066 and considered testimony presented by the applicant and other interested parties, and the recommendations of the various county review agencies; and

WHEREAS, Article 2.E of the Palm Beach County Unified Land Development Code authorizes the Board of County Commissioners to add or modify conditions of approval; and

WHEREAS, the Board of County Commissioners made the following findings of fact:

- 1. The conditional use is not consistent with the Unified Land Development Code because it has not been reviewed for consistency with Section 6.6.E. "Architectural Guidelines" of the Unified Land Development Code.
- 2. With the new condition of approval requiring the project to be certified for compliance with Section 6.6.E. of the Palm Beach County Unified Land Development Code, the conditional use will be consistent with the Unified Land Development Code.
- 3. The amendment of conditions of approval is consistent with the Palm Beach County Comprehensive Plan and with the Unified Land Development Code.

WHEREAS, Section 5.3 of the Palm Beach County Land Development Code requires that the action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that the recommendation of Status Report No. SR 1998-066, to amend Conditions of Approval of Resolution No. R-1999-0701, the development order of Lake Worth 7th Day Adventist Church, Petition No. 1998-066, which approved a Class A Conditional Use (CA) for a church or place of worship, property being legally described as THE SOUTH FOUR (4) ACRES OF THE EAST HALF (E½) OF THE SOUTHEAST QUARTER (SE 1/4) OF THE NORTHEAST QUARTER (NE 1/4) OF THE SOUTHEAST QUARTER (SE 1/4) OF SECTION 25, TOWNSHIP 44 SOUTH, RANGE 42

EAST, PALM BEACH COUNTY, FLORIDA, LESS ROAD RIGHT OF WAY., being located on the N.W. corner of Kirk Road and Melaleuca Lane in the Multiple Family Residential (Medium Density) Zoning District, is approved, subject to the following conditions:

- 1. All previously approved conditions of approval continue to apply unless expressly modified herein. (ONGOING)
- 2. Prior to the issuance of a building permit, the property owner shall submit an application to the Development Review Committee for review and certification that the project is in compliance with Section 6.6.E. of the Palm Beach County Unified Land Development Code,

"Architectural Guidelines." (BLDG PERMIT: MONITORING - Zoning) Commissioner Marcus moved for approval of the Resolution.
