RESOLUTION APPROVING RECOMMENDATION OF STATUS REPORT NO. SR 1980-187F.3 TO APPROVE A DEVELOPMENT ORDER AMENDMENT FOR PROPERTY PREVIOUSLY GRANTED A DEVELOPMENT ORDER AMENDMENT AND A CONDITIONAL USE "A" BY RESOLUTION NOS. R-1998-0736 and R-1998-0738 APPROVING THE PETITION OF TRUSTEES OF INTERNATIONAL CHURCH PETITION NO. 1980-187(F)

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, systematic monitoring and review of approved zoning actions help implement the goals and objectives of the Comprehensive Plan; and

WHEREAS, the notice and hearing requirements as provided for in Article 2.E. of the Palm Beach County Unified Land Development Code have been satisfied; and

WHEREAS, pursuant to Article 2.E., Status Report SR 1980-187F.3 was presented to the Board of County Commissioners of Palm Beach County at a public hearing conducted on August 23, 2006; and

WHEREAS, the Board of County Commissioners has reviewed Status Report SR 1980-187F.3 and considered testimony, and the recommendations of the various county review agencies; and

WHEREAS, Article 2.E. of the Palm Beach County Unified Land Development Code authorizes the Board of County Commissioners to approve development order amendments; and

WHEREAS, the Board of County Commissioners made the following findings of fact:

- 1. With the amendment of conditions of approval, the development orders will be consistent with the Unified Land Development Code including the Traffic Performance Standards.
- 2. The amendment of conditions of approval is consistent with the Palm Beach County Comprehensive Plan and the Unified Land Development Code.

WHEREAS, Section 5.3 of the Land Development Code requires that the action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that the recommendation of Status Report No. SR 1980-187F.3, to approve a Development Order Amendment to amend Conditions of Approval of Resolution Nos. R-1998-0736 and R-1998-0738 the development orders previously granted by the approval of the petition of Trustees of International Church, Petition No. 1980-187(F), which approved a Development Order Amendment to add land area (+16 acres); add Retreat House (10 units) and reconfigure site; and approved a Conditional Use "A" to allow a Congregate Living Facility, Type 3, on property legally described in Exhibit A, being located on the west side of Military Trail, approximately 0.3 mile south of Hypoluxo Road, in the RTS-Residential Transitional Suburban Zoning District, is approved subject to the following conditions:

- 1. All previously approved conditions of approval continue to apply unless expressly modified herein. (ONGOING)
- 2. In order to comply with the mandatory Traffic Performance Standards, the property owner shall be restricted to the following phasing schedule:

No building permits for the site shall be issued after January 1, 2008. A time extension for this condition may be approved by the County Engineer based on an approved traffic study which complies with the mandatory Traffic Performance Standards in place at the time of the request.
