## RESOLUTION REVOKING RESOLUTIONS R-73-621, R-91-243, and R-2005-0601 (CONTROL NO. 1973-00157) AFFIRMING THE ADMINISTRATIVE ABANDONMENT OF ZONING APPLICATION ABN/Z-2008-01682

WHEREAS, the Board of County Commissioners, as the governing body of Palm Beach County, Florida, pursuant to the authority vested in Chapters 125 and 163, Florida Statutes, is authorized and empowered to consider applications related to zoning; and

WHEREAS, Zoning Application ABN/Z-2008-01682 was presented to the Board of County Commissioners at a public hearing conducted on March 30, 2009; and

WHEREAS, Resolutions R-73-621, R-91-243, and R-2005-0601 approving these applications were adopted by the Board of County Commissioners on October 16, 1973, February 26, 1991 and March 24, 2005; and

WHEREAS, the the Board of County Commissioners has determined the request to administratively abandon the development order, as provided for in Article 2 (Development Review Process) of the Palm Beach County Unified Land Development Code (Ordinance 2003-067, as amended) meets the requirements contained therein; and

WHEREAS, the Zoning Director presented the abandonment of the development order to the Board of County Commissioners for ratification on March 30, 2009; and

WHEREAS, Article 2.A.1.K.3.b (Action by BCC) of the Palm Beach County Unified Land Development Code requires that action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Resolutions R-73-621, R-91-243, and R-2005-0601, approving Zoning Application 1973-157, the application of Kings Academy, for a Special Exception granted via Resolution R-73-621 to allow a privated school, a Special Exception to amend the site plan for a private school, to increase the square footage granted via Resolutiones R-91-243 and Status Report to amend Conditions of Approval granted via Resolution R-2005-0601 are hereby revoked.
