WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements, as provided for in Article 2 of the Palm Beach County Unified Land Development Code, have been satisfied; and

WHEREAS, Zoning Application Z-2010-00981 was presented to the Board of County Commissioners at a public hearing conducted on January 6, 2011; and

WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the petitioner and other interested parties, the recommendations of the various county review agencies, and the recommendation of the Zoning Commission; and

WHEREAS, THE BOARD OF COUNTY COMMISSIONERS denied concurrent application DOA-2010-982 requesting to delete the subject site from 441-Atlantic PUD (aka Tivoli Isles) AGR-PUD.

WHEREAS, THE BOARD OF COUNTY COMMISSIONERS found that the application fails to meet the following standards: 3 Compatibility with Surrounding Uses; 4 Design Minimizes Adverse Impact; 5 Design Minimizes Environmental Impact; 6 Development Patterns; and, 9 Changed Conditions or Circumstances as contained in Article 2.B.2.B.

WHEREAS, Article 2 of the Palm Beach County Unified Land Development Code requires that the action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Zoning Application Atlantic 441 West, the Application of Atl 441 W LLC, by ATL 441 W, LLC, agent, for a an Official Zoning Map Amendment to allow a rezoning from the Agricultural Reserve Planned Unit Development (AGR/PUD) Zoning District to the Agricultural Reserve (AGR) Zoning District on a parcel of land legally described in EXHIBIT A, attached hereto and made a part hereof, and generally located as shown on a vicinity sketch as indicated in EXHIBIT B, attached hereto and made a part hereof, was denied on January 6, 2011, with prejudice.
