The day care center shall be limited to a maximum of ninety-nine (99) children. (ONGOING: HEALTH – Health) (Previous Condition J.1 of Resolution R-2005-144, Petition 1992-017E)

Is hereby amended to read:

The daycare center shall be limited to a maximum of one hundred and ninetynine (199) children. (ONGOING: HEALTH – Health)

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:
