## RESOLUTION REVOKING RESOLUTION R-2008-1146 (CONTROL NUMBER 2005-00394) AFFIRMING THE LEGISLATIVE ABANDONMENT OF ZONING APPLICATION ABN/PDD/R-2013-00499

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Resolution R-2008-1146, approving Zoning Application 2005-00394, the petition of Palm Beach Aggregates, by Carlton Fields, P.A. agent, for a Class A Conditional Use to allow Bona Fide Agricultural Uses is hereby revoked.
