RESOLUTION APPROVING RECOMMENDATION OF
STATUS REPORT NO. STR-2007-00346-1
TO REVOKE A USE, TYPE III B EXCAVATION, FROM
RESOLUTION NO. R-2008-0930
APPLICATION NO. CA-2007-1199
CONTROL NO. 2007-346

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, systematic monitoring and review of approved zoning actions help implement the goals and objectives of the Comprehensive Plan; and

WHEREAS, the notice and hearing requirements as provided for in Article 2.E. of the Palm Beach County Land Development Code have been satisfied; and

WHEREAS, pursuant to Article 2.E., Status Report No. STR-2007-00346-1 was presented to the Board of County Commissioners of Palm Beach County at a public hearing conducted on January 9, 2014; and

WHEREAS, the Board of County Commissioners has reviewed Status Report No. STR-2007-00346-1 and considered testimony, and the recommendations of the various county review agencies; and

WHEREAS, Article 2.E. of the Palm Beach County Land Development Code authorizes the Board of County Commissioners to revoke the Class A Conditional Use; and

WHEREAS, the Board of County Commissioners made the following findings of fact:

1. This project was approved on May 22, 2008;
2. The project did not commence;
3. Policy 2.3-e.3 of the Comprehensive Plan states that "Within the Agricultural Production Future Land Use designation, mining may be permitted only to support public roadway projects or agricultural activities...";
4. The Fourth District Court of Appeal of the State of Florida found on October 5, 2011, in Case No. 4D10-60, that "the development order permitting mining in the agricultural production area ... is inconsistent with FLUE policy 2.3-e.3 of the comprehensive plan," effectively nullifying the order; and
5. The revocation of the Type III B Excavation approval is consistent with the ULDC.

WHEREAS, Section 5.3 of the Land Development Code requires that the action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that the recommendation of Status Report No. STR-2007-00346-1, to revoke the Class A Conditional Use to allow a Type III B Excavation, previously granted by the approval of Zoning Application CA-2007-1199, Control No. 2007-346, confirmed by the adoption of Resolution R-2008-0930, on: 31-45-37, ALL TH PT LYG SWLY OF & ADJ TO US HWY 27 (LESS NELY 75 FT ADDL R/W SR 25 & NWLY 250 FT OF SECY 271.21 FT OF NELY 221.75 FT AS MEAS ALONG R/W); and 32-45-37, TH PT OF SW 1/4 LYG SWLY OF & ADJ TO US HWY 27 (LESS NELY 75 FT & TRGLE PAR ADDL R/W SR 25 & S 37 FT), located approximately 6.56 miles south of CR-827 on the west side of US Highway 27, in the AP Zoning District, is approved.

Commissioner Vana moved for the approval of the Resolution.
