WHEREAS, Zoning Condition - Parking 1 of Exhibit C of Resolution R-2016-0211 should have read as shown as follows:

PARKING

1. Prior to the submittal for Final Approval by the Development Review Officer, the Applicant shall revise the Site Plan to indicate a paved pedestrian pathway for parking areas in excess of 400 feet from a public entrance in Building A to the sidewalk within Sansbury's Way. (DRO: ZONING- Zoning)

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

- 1. The foregoing recitals are hereby affirmed and ratified.
- Zoning Condition Parking 1 of Exhibit C of Resolution R-2016-0211 is hereby corrected.
