## RESOLUTION REVOKING RESOLUTION R-1998-1296 (CONTROL NUMBER 1998-00015) AFFIRMING THE LEGISLATIVE ABANDONMENT OF ZONING APPLICATION ABN-2017-01411

WHEREAS, the Board of County Commissioners, as the governing body of Palm Beach County, Florida, pursuant to the authority vested in Chapters 125 and 163, Florida Statutes, is authorized and empowered to consider applications related to zoning;

WHEREAS, the notice and public hearing requirements pursuant to Article 2 (Development Review Procedures) of the Palm Beach County Unified Land Development Code, Ordinance 2003-067 as amended (ULDC), have been satisfied;

WHEREAS, Zoning Application 1998-00015 was presented to the Board of County Commissioners at a public hearing on July 23, 1998;

WHEREAS, Resolution R-1998-1296 approving this Application was adopted by the Board of County Commissioners on August 27, 1998;

WHEREAS, the Zoning Director has determined the request to legislatively abandon the Development Order, as provided for in Article 2 (Development Review Procedures) of the ULDC, meets the requirements contained therein;

WHEREAS, the Zoning Director presented the abandonment of the Development Order to the Board of County Commissioners for ratification on January 25, 2018; and,

WHEREAS, Article 2.A.1.K (Public Hearing Procedures) of the ULDC requires that action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Resolution R-1998-1296, approving Zoning Application CA-1998-00015, the application of West Side Baptist Church, by Robert Basehart, Agent, for a Class A Conditional Use (CA) to allow a Church or Place of Worship is hereby revoked.


