WHEREAS, RG Towers, LLC, Westchester Golf and Country Club Assoc., petitioned the Palm Beach County Board of County Commissioners on February 28, 2019 for a Development Order Amendment to modify the Master Plan to add a use;

WHEREAS, Resolution No. R-2019-0261, adopted on February 28, 2019 confirming the action of the Board of County Commissioners inadvertently contained an error in Exhibit C; and

WHEREAS, ZONING Condition – SITE DESIGN-1 of Exhibit C of Resolution R-2019-0261 should have read as shown as follows:

SITE DESIGN

1. Prior to Final Approval by the Development Review Officer (DRO), the Site Data Table for the Master Plan shall be revised to update the uses and acreage. (DRO: ZONING - Zoning)

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

1. The foregoing recitals are hereby affirmed and ratified.
2. ZONING Condition – SITE DESIGN-1 of Exhibit C of Resolution R-2019-0261 is hereby corrected.
