Subject to an Easement for Drainage Purposes over the North 25 feet.

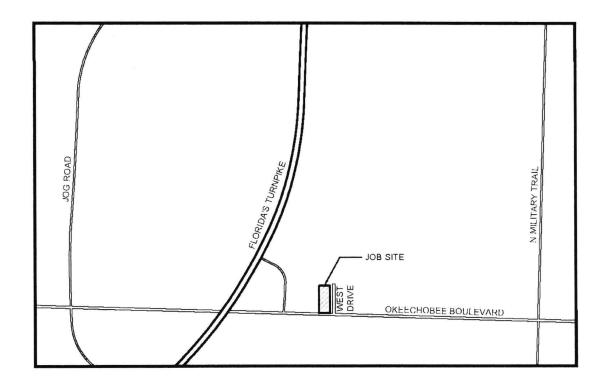
