WHEREAS, Article 2.B.6.C (Board Action) of the ULDC requires that action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Resolution R-1984-1165 approving Zoning Application SE-1984-00046, the application of New Life Country Church, Inc., by David E. Walker, Agent, for a Special Exception to allow a church, as amended by Resolution R-1989-1057, is hereby revoked.


