RESOLUTION REVOKING A SPECIAL EXCEPTION ADOPTED BY RESOLUTION R-1974-0765 (CONTROL NUMBER 1974-00122)

WHEREAS, the Board of County Commissioners, as the governing body of Palm Beach County, Florida, pursuant to the authority vested in Chapters 125 and 163, Florida Statutes, is authorized and empowered to consider applications related to zoning;

WHEREAS, the notice and public hearing requirements pursuant to Article 2 (Application Processes and Procedures) of the Palm Beach County Unified Land Development Code (ULDC), have been satisfied;

WHEREAS, Zoning Application 1974-122, an Application by Methodist Church District Board of Missions and Church Extensions of West Palm Beach Inc., submitted by John F. Springer, Secretary of the Board, for a Rezoning from AG-Agricultural District to RS-Residential Single Family District and a Special Exception to allow a Church including Sanctuary Facilities, Educational Building and Administrative Offices and subject to Conditions of Approval, was presented to the Board of County Commissioners at a public hearing on August 29, 1974, and adopted by Resolution R-74-0765 on September 17, 1974;

WHEREAS, Zoning Application ABN-2021-01941 was submitted on behalf of Christ Fellowship Church by Cotleur & Hearing, Inc., to abandon the Special Exception for a Church including Sanctuary Facilities, Educational Building and Administrative Offices, as previously granted by Resolution R-74-0765 as was presented to the Board of County Commissioners at a public hearing on August 29, 1974;

WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the Applicant and other interested parties, and the recommendations of the various County Review Agencies;

WHEREAS, the Board of County Commissioners hereby incorporates by reference the Findings in the staff report addressing the Standards contained in Article 2.B (Public Hearing Processes) for a Development Order Abandonment;

WHEREAS, the Board of County Commissioners pursuant to Article 2, Application Processes and Procedures of the ULDC is authorized and empowered to consider, approve, approve with conditions or deny the request;

WHEREAS, the Palm Beach County Survey Section may administratively correct any scrivener's errors that will not significantly impact the overall boundary of the adopted legal description; and,

WHEREAS, Article 2.B.6.C (Board Action) of the ULDC requires that action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that the Special Exception to allow a Church including Sanctuary Facilities, Educational Building and Administrative Offices and subject to Conditions of Approval, adopted by Resolution R-74-765, on a parcel of land generally described as shown on the legal description in Exhibit A, is hereby revoked. The remainder of Resolution R-74-765 shall remain in full force and effect.
